RECOGNITION. "The best part of trying cases is knowing that we're able to change lives for the better," says Grassini. "Our clients and our cases allow us to force corporate America to make changes that protect and preserve a safer environment for consumers." Last year the firm represented a couple who lost their two daughters in a lengthy struggle against Enterprise Rent-A-Car, which rented the girls a car knowing it was subject to a safety recall. When that case went to trial and the jury rendered a \$15 million verdict, there was national press. The public's recognition of Enterprise's egregious acts led to the California legislature to enact the Raechel and Jacqueline Houck Safe Rental Car Act of 2011.

THE OTHER LAWYERS AT GRASSINI & WRINKLE ARE BUILDING CONSIDERABLE REPUTATIONS in their own rights. Katie Grassini and Lars Johnson won a seven-year battle that ultimately went to the California Supreme Court and changed the law to better protect victims of HIV. The decision, which then resulted in a \$12.5 million verdict at trial, allows innocent victims who contract HIV from a spouse or other to seek recovery if they are able to show that the defendant "should have known" that he or she might have been infected. Johnson then teamed with Jamie Kurtz to win a \$4.2 million battle against 20th Century Fox regarding the filming of *Flight of the Phoenix*. When an insurance company refused to deal fairly with a stockbroker, calling the plaintiff's demand "outrageous," John Raders tried the case and received an award double the insurer's offer.
